





Financial statement analysis

Industry comparison	The financial statement analysis is based on the financial statement data of Oy Authors Distillery Ltd in the accounting period as at 31.05.2021. The analysis also utilizes the data of the previous accounting period. The company has been founded less than five years ago, so uncertain factors characteristic of new companies may be related with its development. The auditor has given further information which may have an impact on the interpretation of the financial statements. The comparison includes 36 companies in the industry class 11010 (Distilling, rectifying and blending of spirits) from the period 2020. The
Volume	risk of bankruptcy in the line is 0,0 %, and the risk of payment defaults 4,6 %. The risk of payment defaults is close to the median level for all companies. The turnover of Oy Authors Distillery Ltd is very small (30 tEUR) in relation to all active companies. The company's turnover in relation to the
Profitability	balance sheet total is small. Thus, part of the ratios and comparisons are left out of the examination. Ratios proportioned to the turnover are not interpreted, because the company's turnover is small, proportioned to the balance sheet. The central
	ratio for profitability, return on investment, is poor (-49,3 %). This is clearly lower than the average in the line (median -1,8 %). If, instead of the return on investment, the return on assets is calculated, taking also into account interest-free loans, the return ratio is -45,5 %. The share of interest-free loans in the company's balance sheet is small, due to which the return on assets and the return on investment are close to each other. The return is poor, in relation to the line of business (-1,8%). The company's cash-flow based operational surplus is
Liquidity	negative. The liquidity is very good, measured by current ratio (6,3), which is considerably better than the average in the line (median 1,3). On the basis
Solvency	of this, the company's financial buffer is bigger than normal. The accounts payable turnover of the company is long, 241 days, compared with the median value in the line (63 days). The solvency of Oy Authors Distillery Ltd is very good, measured by equity ratio (72,1 %). The median in the line is 21,4%, so the company is
Summary and remarks	exceptionally solvent in its line. The solvency has improved considerably from the previous period. The company's net gearing is -0,7, which can be considered very good. Because the company is young, very small and poorly profitable, an obvious risk is involved.


